Algorithm to Define Outcome	Definition 1: Evidence of an ICD-9-CM or ICD-10-CM diagnosis code used to define nasal septal perforation AND evidence of a CPT-4 procedure code for nasal septal perforation repair within 90 days of the nasal septal perforation diagnosis. Both conditions may occur in any care setting. The final nasal septal perforation outcome date is set to the date of the diagnosis code.			
	Definition 2: Evidence of an ICD-9-CM or ICD-10-CM diagnosis code used to define nasal septal perforation AND evidence of a CPT-4 procedure code for nasal septal perforation repair within 180 days of the nasal septal perforation diagnosis. Both conditions may occur in any care setting. The final nasal septal perforation outcome date is set to the date of the diagnosis code.

Glossary

Care Setting - type of medical encounter or facility where the exposure, event, or condition code was recorded. Possible care settings include: Inpatient Hospital Stay (IP), Non-Acute Institutional Stay (IS), Emergency Department (ED), Ambulatory Visit (AV), and Other Ambulatory Visit (OA). For laboratory results, possible care settings include: Emergency department (E), Home (H), Inpatient (I), Outpatient (O), or Unknown or missing (U)

Outcome - outcome of interest (either primary or secondary)

Principal Diagnosis (PDX) - diagnosis or condition established to be chiefly responsible for admission of the patient to the hospital. 'P' = principal diagnosis, 'S' = secondary diagnosis, 'X' = unspecified diagnosis, '.' = blank. Along with the Care Setting values, forms the Caresetting/PDX parameter.

Query Period - period in which the modular program looks for exposures and outcomes of interest **Request Send Date** - date the request was sent to Sentinel Data Partners
